All candidates must register via the Academic Scholarship link before applying for any other scholarship.

To be eligible for a Perth College Scholarship, all candidates must be an Australian citizen or permanent resident.

Applicants applying for the Music and Performing Arts Scholarships are also required to attend an audition (dates to be confirmed). Shortlisted applicants will be notified closer to the time for their specific time and day.

Kindly note that for boarding or overseas families located 400km or more away, alternative arrangements may be organised. If you wish for this to occur, please register using the Academic Scholarship Remote Location link (for students in Years 7, 8, 9, 10 and 11 in 2026 - sitting the exam in a remote location).

Academic Scholarship

CURRENT AND NEW STUDENTS | YEAR 7 TO YEAR 11 PART-REMISSION OF TUTITION FEES

Academic scholarships are offered to students entering Year 7 to Year 11 in 2026.

DESCRIPTION

Academic scholarships are awarded to current or new students who wish to enter Perth College in Year 7 to Year 11. These scholarships offer part remission of tuition fees for the duration of the student's time at Perth College. Students will be tested and selected in the year preceding the year of entry.

The scholarship is based on the assessment of each application, taking into consideration the results from the scholarship examination, school reports and relevant supporting documents, along with a range of other achievements.

General Excellence Scholarship

CURRENT AND NEW STUDENTS | YEARS 5, YEAR 7 TO YEAR 11 PART-REMISSION OF TUTITION FEES

General Excellence scholarships are offered to students entering Year 5 and Year 7 to Year 11 in 2026.

DESCRIPTION

The General Excellence scholarship is awarded to a current or new student who wishes to enter Perth College in Year 5 and Year 7 to Year 11. This scholarship offers part remission of tuition fees for the duration of the student's time at Perth College. Students will be tested and selected in the year preceding the year of entry.

The scholarship is based on a range of the student's achievements across various activities, including academic, co-curricular, leadership, service, innovation and entrepreneurship.

SCHOLARSHIP REQUIREMENTS

To qualify for the scholarship, applicants are required to:

- complete the online scholarship registration by Wednesday 29 January 2025
- sit the scholarship exam held at Perth College on Saturday 8 February 2025
- if shortlisted, attend an interview with the Principal.

In addition to the online application, the following documents need to be uploaded no later than **Wednesday 29 January 2025** (Friday 24 January 2025 for remote and overseas registrations):

- Two most recent school reports
- Most recent NAPLAN results

Music Scholarship

CURRENT AND NEW STUDENTS | YEAR 7 PART-REMISSION OF TUTITION FEES

Music scholarships are offered to students entering Year 7 in 2026.

DESCRIPTION

Music scholarships will be awarded to current or new students who wish to enter Perth College in Year 7. These scholarships offer part remission of tuition for the duration of a student's schooling; students will be tested and selected in the year preceding the year of entry.

The scholarship is based on the assessment of each application whilst taking into consideration the student's achievements across a breadth of activities, including academic and co-curricular, leadership and service, and the ability to participate in the life of the School.

Applicants should have outstanding musical ability and are advanced instrumentalists/vocalists on their musical instrument of choice. They should be advanced and dedicated instrumentalists and may have studied for AMEB and/or Trinity College exams on at least one instrument. Applicants should be the equivalent of Grade Three exam level or above. Applications must be supported with a written reference from the student's current Music teacher. Please upload references with all other documentation.

Short listed candidates for this scholarship are required to attend an audition with the date and time to be confirmed. Applicants who have not been successful in obtaining an audition will be notified. After the audition process, shortlisted candidates will be invited for an interview with the Principal.

TERMS OF MUSIC SCHOLARSHIP

Music scholarships holders will be expected to:

- Be a member of one of the major instrumental ensembles as appropriate
- Be a member of a school choir
- Maintain a high level of achievement on their chosen instrument
- Study this subject as an elective subject from Year 7 to Year 10 and an ATAR subject in Years 11 and 12, maintaining a high level of effort and achievement and acting as a positive role model to others
- Be supportive and contribute to the musical life at Perth College

AUDITION REQUIREMENTS

- Accompanists or backing tracks should be used at the audition where appropriate and should be provided by the applicant
- At the audition, the student will be asked to perform two short contrasting items of their own choice, no longer than 3 minutes per piece. Each piece can be performed on two different instruments if applicable
- The audition will include a listening test and a brief interview
- The audition will take approximately 15 minutes.

Performing Arts scholarships are offered to students entering Year 10 in 2026.

The Performing Arts scholarship will be awarded to a current or new student who wishes to enter Perth College in Year 10. It will offer part remission of tuition for the duration of a student's schooling. Students will be tested and selected in the year preceding the year of entry.

Applicants who have not been successful in obtaining an audition will be notified. After the audition process, shortlisted candidates will be invited for an interview with the Principal.

TERMS OF PERFORMING ARTS SCHOLARSHIP

Music scholarships holders will be expected to:

- Be a member of one of the major performance ensembles as appropriate
- Be a member of eP!C Youth Theatre Company (Dance and/or Drama)
- Maintain a high level of achievement in their chosen area of interest
- Study this subject as an elective subject from Year 10 and an ATAR subject in Years 11 and 12, maintaining a high level of effort and achievement and acting as a positive role model to others
- Be supportive and contribute to the Performing Arts community at Perth College.

AUDITION REQUIREMENTS

- Accompanists/props/backing tracks should be used at the audition where appropriate and should be provided by the applicant
- At the audition, the student will be asked to perform two short contrasting items of their own choice, no longer than 3 minutes per piece
- The audition will include a short workshop and a brief interview
- The audition will take approximately 15 minutes

The Wulili Indigenous Student Scholarship is offered to a new student entering Year 7 to Year 11 in 2026.

DESCRIPTION

The Wulili Indigenous Student Scholarship is offered to an Aboriginal and/or Torres Strait Islander student who is entering the School in Years 7 to Year 11 and who may not otherwise be able to come to the School.

The Wulili Scholarship is funded by the Perth College Foundation and the amount provided will depend on the individual family's capacity to contribute and the extent of other funding they are receiving. It is expected that the family will make some monetary contribution towards the child's ongoing education.

Students are selected based on achievements across a breadth of activities including academic, co-curricular, leadership, service and innovation/entrepreneurship strengths.

APPLICATION CRITERIA

To be considered for the Wulili Scholarship, students apply direct to the School in the year prior to entry. Students are required to submit a cover letter, addressed to the Principal, responding to the following questions:

- Tell us about yourself and your family/traditional background
- Why you would like to come to Perth College
- What you feel you can bring to our School Community

In addition, to the cover letter the following documents will also need to be provided:

- Two most recent school reports
- Most recent NAPLAN results (if available)
- Written essay: 350-500 word response to the following question:

"Leadership is about making a positive impact so that others can benefit more than you. Write about how you hope to show this in your own community, once you have finished school."
